

Christy gets mad and changes her mind about letting me see Megan...

Note: Christy initiated the texts on Feb 19th 2011. She starts off with saying that she is unaware of any plans that I have to pick up Megan even though we have been driving there every weekend for the past 4 years AND have continued to do so recently, even though Christy has not been allow us to take Megan. We would drive back 2 hours to La Quinta without our daughter.

Additionally, since Christy has suddenly been demanding that I get hers and Megan's permission, I texted Christy on the 9th and reminded her of our plans to take family portraits.

During the text exchange Christy abruptly changes her mind about letting me see Megan. ADDITIONALLY, she claims Megan has cramps and will not be attending gymnastics, so now we won't even be allowed to see her. She knows that we show up at practice every weekend.

Feb 9th Text. Me to Christy: (All texts are Bold and in Italics)

Reminder we r taking family portaits the weekend of the 19th . I will be picking up Megan and will call or text to make arrangements with YOU.

I received no response.

10 days later...

Feb 19th 2011

Christine to me:

I am not sure if u were planning on taking Megan today however I am not aware of any planned visit. Please keep me informed of when you will be visiting megan. Also if she chooses to go with you please allow her to call me. The last time you took her you refused communication and I am hoping that doesn't occur again. Thanks.

Me to Christy:

You are well aware that we pick up Megan every weekend except when you do not allow us.

Christy to me:

No that has not been the case. We have always arranged visits. Also I have never not allowed visits in the past, rather lately Megan has expressed her concerns with your visitation and fears going to your house. We need an arranged visitation prior to you taking her. I had plans with her this weekend. Also Megan has cramps and will not be at gym. I have an appointment on tues for counseling for Megan to get to the reason why she refuses to go to your house and her feelings towards this situation. Thanks.

- Notice how Christy abruptly changes her mind, she knows we show up at gym every weekend anyways, so she also is keeping Megan out of gym. Megan's menstrual cycle is on whatever weekend is convenient for Christy...and now Megan.

Me to Christy:

I am glad you made an appointment for a counselor. I would like to know the name of the therapist please. Thank u

Christy to me:

I will text it to you after her first visit and let you know if we could all sit down with her in the near future.

- Note: Christy doesn't want me to talk to the therapist and tell her the truth. The therapist later called me on her own and insisted that I come. On the day that I was to come see the therapist for the first time, I received about 16 calls and text messages trying to keep me from coming. [Click Here, see text/calls list](#)

Christy to me:

Also, please text me your address.

- I have lived here for 5 years. The reason she doesn't know my address is she has never been to our daughter's other home to pick her up or drop her off.

Me to Christy:

So u r refusing to give me name of therapist?

Christy to me:

Not at all I want to make sure she is right for Megan.

- She wants someone who she can tell her side of the story to and have her believe it.

Christy to me:

Her name is Shirley Stutson. Pls text me ur address. Thnks.

Me to Christy:

U have me address. Do u want me to forward the text from u where u said u sent police to my house on Christmas?

- Christy and Michael had claimed to have sent the police to our house on CHRISTMAS. Yes, I was being a smartass.

Christy to me:

Do you have plans with Megan this weekend? If so I can break mine with her.

Christy gets mad and changes her mind about letting me see Megan...

Christy to me:

Look I don't want to play games or argue...pls text me your address so I have it on file.

Thanks.

- I have lived here for 5 years. The reason she doesn't know my address is she has never been to our daughter's other home to pick her up or drop her off.

Me to Christy:

XXXXX, La Quinta, CA 92253

- We were unable to pick up or see Megan this weekend. It may seem like Christy is offering to ALLOW me to see Megan. But she actually denied me access again. Whenever I am able to get her on the phone, she simply states to ask Megan knowing that Megan will say no because they have made previous plans or because Megan is instructed to do so.
